




Our proposals per the guidelines of government of India are pending for final order in the concerned ministries, including labour & employment

We have been informed that Government of India has released Second Instalment (Central Share) to government of West Bengal under **Rashtriya Krishi Vikas Yojana**, 2015-16 for normal RKVY and BGREI to be implemented through various implementing agencies. The proposal for fund allocation is now pending in the Ministry of Agriculture.

In the light of our experience, infrastructure facilities and a work force of more than 10,000 local rural workers available with us, we may claim that we have the capability to take up any scheme for implementation of MGNREGA in the stipulated period as identified in the scheme to scheme project in any village of 1477 villages in 10 blocks of the district.

Organization have been participated in several Government programmes and implementing their own basis like Swachabharat Abhyan, Betipadavo Betibachovo and Rural Health awareness programmes, registered in Neeti Aayog, VO Darpan Programme and Implementation of Ajeevika, National Rural Development Programme, NREP etc.
