ORDERS

Whereas the Block Level Screening Committees have recommended the applicants, now sanction is accorded with the approval of the District Magistrate & Collector, Howrah and the Chairman of the DLSC for an amount of **Rs.60,000/-** only to the farmer of the following **block** in the scheme **BGREI (RKVY) /FSSM /State Share** as per fund released under the G.O.NO.736-(Sanction)-Nab/9M-34/2016 dtd. 27/09/2016 of the Deptt. of Agriculture Govt. of WB read with allotment under No. 90-Sanction/BGREI/DAWB dtd.03/11/16 of the DAWB to implement the FSSM scheme for the Farmers to get machineries in subsidy as per his choice during the year 2016-17.

The **DLSC's approved list** is sent herewith to the respective Asstt. Director of Agriculture (Administration), Subdivision for **Treasury drawal**. **As per directive of the Govt. the Treasury shall** send money through RTGS/ NEFT as '**front end subsidy**' to the Bank Branch where the respective individual beneficiary has KCC a/c. **To ease and facilitate the smooth flow of fund and crediting the amount to banks, a functional arrangement is made with the approval of the District Magistrate and Chairman DLSC, Howrah that, the respective DDOs shall arrange to send money to banks through the official accounts of the Asstt. Director of Agriculture, Blocks.**


The Asstt. D.A. Block will send applications together with approved list to the concerned Bank Branch. He will inform the farmers to approach the Bank Branch seeking sanction of KCC loan for the balance amount or to deposit rest of the amount as own contribution to the respective Banks/Branches. After getting the subsidy the Bank/Branches shall issue **Supply Order** to the supplying agencies as opted by the farmers as per approved list with a copy to the Asstt. D.A. Blocks. The Bank/ Branch may collect the **Debit/ Demand note/ Debit authorization Letter** from the farmers against their A/Cs for smooth payment to the Suppliers/ Dealers. After delivery and receiving Claim Bills from the supplier together with receipted delivery Challans and Other documents etc the Bank shall release the total amount (including KCC loan / farmer's contribution + Govt. subsidy) to the dealer /manufacturer/ supplier. **Banks are not to claim any processing fee for this purpose. The amount of SUBSIDY can not be adjusted with any outstanding loan of the concerned farmer.** During supply of machineries photographic documentation of the individual farmer with implement should be taken.

The expenditure for subsidy shall met out of the allotment placed to the Asstt. Director of Agriculture (Admn.) Howrah and Uluberia Sub Divisions vide No.1338/BGREI(RKVY)/FSSM/State Share/16-17 dtd. 14/12/16 of the Under Signed

The DDOs and the Implementing Officers should follow the financial proprieties as per norms and guidelines.. As per G.O. No 1074-Nab dtd. 26/09/2016, **Distribution Certificate to be collected as per Annexure-V and Inspection Report to be sent as per Annexure -VI of the above G.O. The minimum no. of Inspection for Asstt DA, Block is 10% and for Asstt. DA(Admin) sub-div -02% of distribution.**

The distribution of the machineries may be done preferably at camp mode and each machine should bear a metal tag/ sticker in Bengali format as in G.O.
