NOTIFICATION

The Governor is pleased to notify the name of Implementing Insurance Agencies (IA), Sum Insured (SI) and Indemnity Level for Kharif - 2016 season in continuation of this department Notification No. 227-Nab/Crop Ins./7C-01/2016, dt. 01.03.2016 in respect of implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) in this state.

1. The Implementing Insurance Agencies have been selected through e-tendering following the cluster approach, a cluster comprising a number of districts, in terms of the Operational Guidelines of PMFBY(Section XXIII and Para 8) and from empanelled companies by Ministry of Agriculture & Farmers Welfare , Government of India
2. For each cluster and crop combination, only one IA has been selected for implementation of PMFBY Kharif 2016 in the state.

6. The Indemnity level will be 80% for Aman Paddy and Jute. For Aus paddy and Maize the indemnity Level will be 90%.
