In partial modification of this Office Order No.50(60)-Farm dated 29th April 2015 the selling rate of different farm grown seeds, seedlings, planting materials and organic inputs for the year **2016-2017** as fixed up are enclosed herewith (Statement I to IV) for information and taking necessary action by all concerned. These rates are ex-farm and exclude bag for truthfully labeled seeds. The foundation and certified seeds are to be sold in bag and the Deputy Director Agriculture (Seed Certification), West Bengal, will intimate the size of the bags of each type of Foundation / Certified seeds.

If the selling rate of any seed/seedling remains un-addressed in the enclosed statements, the Additional Director of Agriculture, North Bengal Region/concerned Joint Directors of Agriculture/ Deputy Directors Agriculture (Admn.), as the case may be, will fix up the selling rate for that commodity only from his end with prior approval of the undersigned.

The rates concern the Department of Agriculture, Government of West Bengal and will come into effect from 11th May, 2016 and shall remain valid until further order.

All concern had already been informed through the earlier order that the Agriculture Department will follow the same selling rate as fixed up by State Level Selling Price Fixation Committee of the Department of FPI & H, W.B. with respect to the farm grown seeds and planting materials of Horticultural Crops pertaining to that Department. The related order of the selling price for the year 2016-17 of the Department of FPI & H will be circulated to all concerned on receipt of the same from that Department and those rates will be effected onwards accordingly. The rates of fodder and fodder seeds will be followed as per the rates of the Animal Resource Development Department, West Bengal.


