ORDER

In terms of Order No.828-Nab/12E(Inputs)-04/2013 Dated 29.05.2018 of this Deptt., for supply and installation of IT equipments for the Secretaries of Agriculture Department at Writers' Building and Nabanna, Sreerampore Wholesale Consumers' Co-operative Society Ltd. of 16, Satish Chandra Ghose Lane, Serampore, Hooghly has supplied and installed the same. In this connection, Sreerampore Wholesale Consumers' Co-operative Society Ltd. has submitted an invoice of an amount of Rs. 99,616/- (Rupees Ninety nine thousand six hundred sixteen) only including GST @ 18% only, for payment of the cost of IT equipments.

In view of the above, the undersigned is directed to say that the Governor is pleased to sanction and release an amount of Rs. 99,616/- (Rupees Ninety nine thousand six hundred sixteen) only in favour of Sreerampore Wholesale Consumers' Co-operative Society Ltd. for payment of the above invoice from the fund of NeGP-A scheme lying in the A/c of WBSFSA.

Out of the total amount of Rs.99,616/-, an amount of **Rs.97,928/- (Rupees Ninety seven thousand nine hundred twenty eight)** only shall be released in favour of Sreerampore Wholesale Consumers' Co-operative Society Ltd. through an A/c Payee cheque/RTGS and **Rs.1,688/- (Rupees One thousand six hundred eighty eight)** only shall be deducted as TDS @ 2% and the same may be deposited in Form T.R.-7 under recovery and credit account under Section 194C(1) of the Income Tax Act, 1961.


