

Out of the amount of ₹ 64,173.00 (Rupees Sixty four thousand one hundred seventy three) only, an amount of ₹ 63,445.00 (Rupees Sixty three thousand four hundred forty five) only will be released in favour of **West Bengal Electronics Industry Development Corporation Limited (WBEIDC)** through RTGS and ₹ 728.00 (Rupees Seven hundred twenty eight) only will be deducted as TDS (as per Section 194 J of I.T.Act, 1961) and same amount will be deposited under the head of recovery and credited to "8658-Suspense Accounts-00-112-Tax Deducted at Source (TDS) Suspense."
