
The undersigned is directed to state that the Governor is pleased to sanction and release an amount of ₹ 3,08,617.00 (Rupees Three lakh eight thousand six hundred seventeen) only in favour of **West Bengal Electronics Industry Development Corporation Limited (WBEIDC)** towards payment of Bill No.ESI/BDS/17-18/00619 Dated 22.03.2018 in connection with '*Technical & Content development of the application system & Misc. The undersigned is further directed to say that the entire amount ₹ 3,08,617.00 (Rupees Three lakh eight thousand six hundred seventeen) only will be released for "Matir Katha 2.0" project from the RKVY fund for this purpose lying in the account of West Bengal State Food Security Agency (WBSFSA), Kolkata.

Out of the amount of ₹ 3,08,617.00 (Rupees Three lakh eight thousand six hundred seventeen) only, an amount of ₹ 2,82,463.00 (Rupees Two lakh eighty two thousand four hundred sixty three) only will be released in favour of **West Bengal Electronics Industry Development Corporation Limited (WBEIDC)** through RTGS and ₹ 26,154.00 (Rupees Twenty six thousand one hundred fifty four) only will be deducted as TDS (as per Section 194 J of I.T.Act, 1961) and same amount will be deposited under the head of recovery and credited to "8658-Suspense Accounts-00-112-Tax Deducted at Source (TDS) Suspense."
