Out of the amount of ₹ **11,38,331/-** (Rupees Eleven lakh thirty eight thousand three hundred thirty one) only, an amount of ₹ **11,33,737.00** (Rupees Eleven Lakh Thirty Three Thousand Seven Hundred Thirty Seven) only will be released in favour of **West Bengal Electronics Industry Development Corporation Limited (WBEIDC)** through RTGS and ₹ **4,594.00** (Rupees Four Thousand Five Hundred Ninety Four) only will be deducted as TDS (as per Section 194 J of I.T.Act, 1961) and same amount will be deposited under the head of recovery and credited to "8658-Suspense Accounts-00-112-Tax Deducted at Source (TDS) Suspense."
