SINCHAYEE YOJANA (PMKSY) PER DROP MORE CROP IN West BENGAL**

The CEO & Secretary, WBSWDA, invites expression of interest from any reputed manufacturers /agency and financially sound firm, having suitable technical, financial and managerial capabilities satisfying the following condition:-

1. Should be a manufacturing units/West Bengal State Government Agency or Corporation or Undertakings and Installing BIS and ISI standard Drip/ Sprinkler materials.
2. Should have authorised dealer/network/offices in West Bengal with minimum two (2) years experience in designing, planning, estimating and installing drip/sprinkler irrigation system in the field of the farmers of India.
3. Should be able to provide maintenance and Agro-economical service to the farmers. (four times in the first year, two times in the second year)
4. Should have annual financial turnover of Rs 2.00 crore (Rupees two crore) for the last two (2) years i.e. 2014-15 and 2015-16.
5. Manufacturers/ firms should have manufacturing units/head office/area office/ branch office in West Bengal
6. Authorised persons/ agents of manufacturers/West Bengal State Government Agency or Corporation or Undertakings are not allowed to apply.

Physical copies of completed application, stating detail of manufacturers/ West Bengal State Government Agency or Corporation or Undertakings along with the cost of installation of drip /sprinkler irrigation system, considering different land size and using standard BIS equipment /material for :-

- a) Drip Irrigation-
 - i) Wide Spaced Crop, –for more than 2m spaced crop
 - ii) Wide Spaced Crop - for 2m to 4m spaced crop
 - iii) Close Spaced Crop, - for 1.2m to 2m spaced crop
 - iv) Close Spaced Crop - for less than 1.2m spaced crop.
- b) Micro Sprinkler
- c) Mini Sprinkler
- d) Semi- Permanent sprinkler
- e) Portable Sprinkler
- f) Large Volume Sprinkler
