
Sealed quotations in plain paper are hereby invited from the bonafide commercial vehicle owners (Scorpio/Swift Dezire/Sumo Gold/Bolero etc.) having commercial permit for hiring, **as and when required** in connection with the supervision of New Generation Watershed Development Project under PMKSY-WDC-2.0 schemes located usually at remote villages under different Blocks of Purulia District.

The quotation should reach to the office the undersigned on and before 26/05/2022 up to 1:00 PM and will be opened at 2:00 PM on the same day in presence of the quotationers, if thereby any.

In case of **non-availability of vehicle with commercial permit**, non commercial vehicle owners may apply. However, commercial permit holders will be given preference.

Terms & Conditions:

1. Rate should be quoted separately in figures and words.
2. The quoted rate should not exceed the maximum permissible limit of present hiring rate for **per day of plying** as fixed by the competent authority of the Government.
3. Consumption of **Lubricant Oil (Mobil) and fuel (Diesel) will be provided by this office as per existing departmental norms**. However, vehicle owners should indicate the no. of Km of running / litre of fuel and Mobil at the time of submission of their quotations.
4. The vehicle should be in good working conditions.
5. The owner should submit the photocopy of the blue book and up to date tax paid certificate indicating commercial permit at the time of submission of quotation.
6. No overtime will be entertained to the driver in case of early arrival or late departure.
7. In case of any accident take place during hiring, the matter should be met up by the vehicle owner. If any damage of the vehicle occurs during hiring, the office will not entertain any repairing cost.
8. If any legal proceedings arise during hiring, the matter should be met up by the vehicle owner.
9. Initially the contract for hiring will be six months and it may be extended for a specific period if the office of the undersigned and owner of the vehicle mutually agreed the condition of contract at that time.
10. The authorities reserve the right to reject any or all the quotations without assigning any reasons and will not to be bound to accept the lowest or any quotation.
11. Quotation should be apply in attached specific format (Annexure –A).


